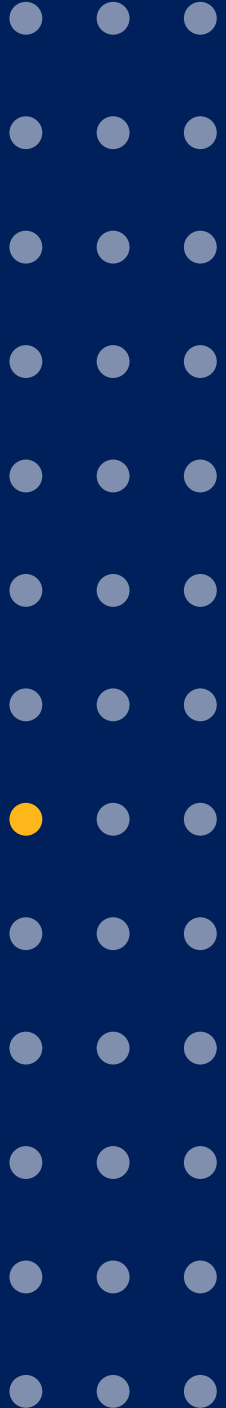

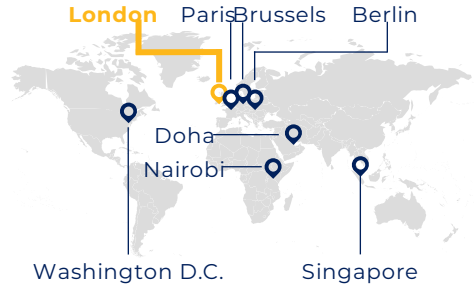

LITIGATION COMMUNICATIONS:

Managed communications and proactive press office, including in-court support for the UK and Delhi High Court, for three international banks pursuing a high-profile individual for loans in the million pounds to help enforce a judgment debt decision.



CLASS ACTIONS:

Defendant: In a challenging media environment, developed a data-led strategy to help an international brand defend its reputation in one of the largest consumer class actions, including managing the settlement of that action

Claimant: Launched the Lloyd v. Google case, including managing a ground-breaking digital first approach using social media which generated 10,000 sign-ups in the first week.



ARBITRATION:

We secured coverage in international, regional and local media supporting the client's legal arguments, highlighting evidences of fraud, and countering misinformation by the other side.
